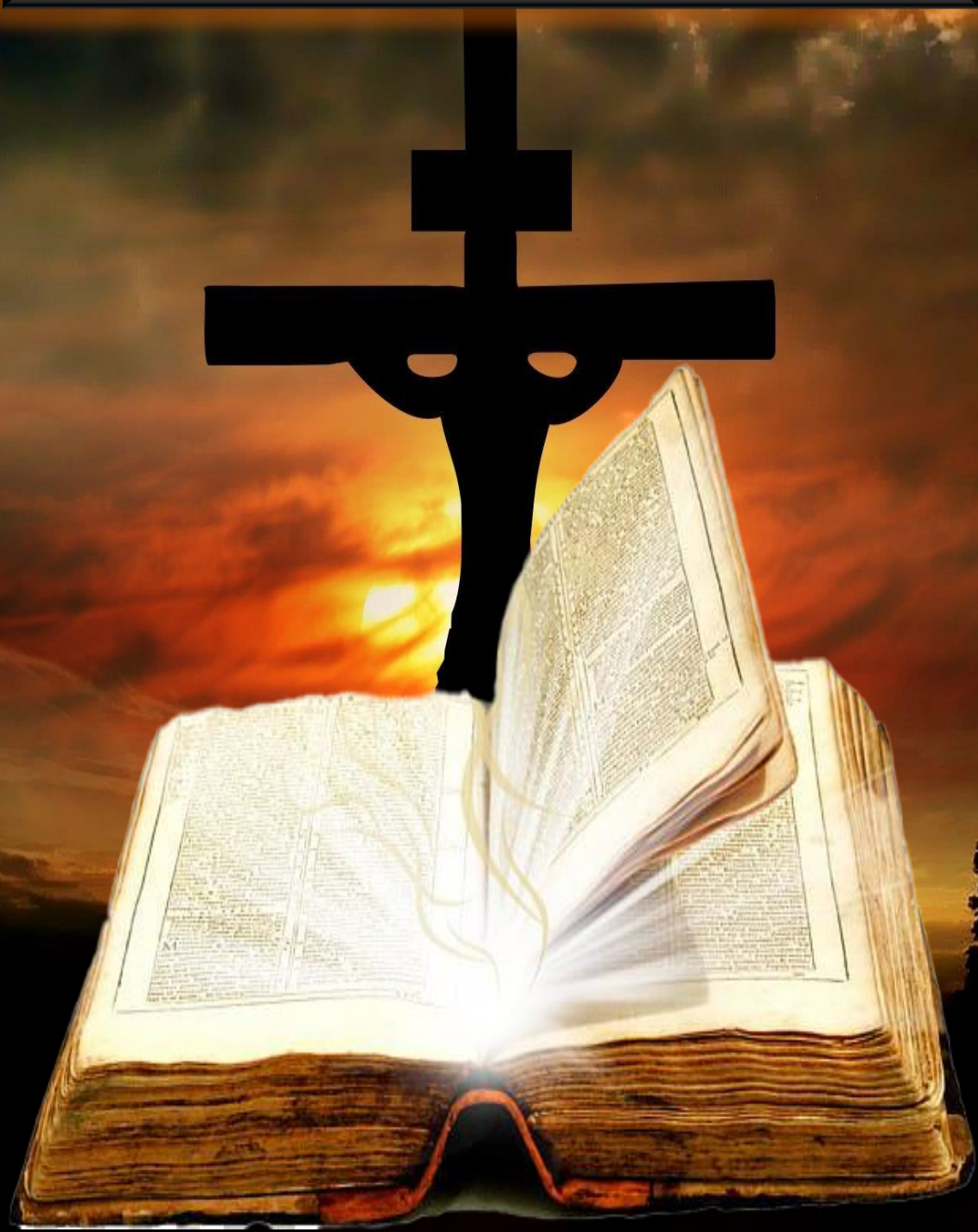

Introduction - The Platform of Marriage

This book is for me to flow in the spirit and chart my path with the important milestones leading to my experience with the Almighty God. The God of Heaven. The God of creation. The God of Abraham, Isaac, and Jacob. The Father of Jesus Christ of Nazareth. I would like for people to know that God is present everywhere to everyone if they choose him, but it's your free will to access his power for your spiritual light to come on. He is a Spirit and those that worship him must worship him in spirit and truth (John 4:24). When I began to put the teachings of Jesus Christ as my standard of practice, it was at my job in 2006. I was in a covenant marriage which was God's platform to extend his blessings to man and woman. God used the covenant of marriage to manifest himself to me. He was also speaking to my husband through my experience, but it was his free will to choose who he would serve (Joshua 24:15). Although God has always been hovering over my life, like in Genesis 1:1-2

when God hovered over the waters. I didn't know him, and I was formless in my spirit. He couldn't see the spirit he formed before my mother's womb (Jeremiah 1:5) because the darkness (my sinful nature) of this world covered my light, but he was present and waiting patiently for me to flicker.

Chapter 1 – I found my Life

My experiences on earth prepared and equipped me for the promise that can only be transferred through spiritual or physical death then God's WILL can be released. I had to die to every connection to the life I was living on earth to enter the Will of God. Jesus said, "He who finds his life will lose it, and he who loses his life for My sake will find it" (Matthew 10:39, NKJV). I found my life on January 14, 2013, but my old life had to die. I was born again in my spirit and the Holy Spirit began to guide me. This is the experience that should have taken place in 1987 when I was saved, but an enemy blocked my salvation. God allowed it because as Jesus said, Let both grow together until the harvest (Matthew 13:30). It was good that I was afflicted because I was growing physically so I could gain strength in God and learn his ways (Psalms 119:71). Before I found my life, the scripture on my wedding program dated October 10, 2004, was Genesis 2:22-



24, but after the Holy Spirit reflected on my life John 10:10 was the true platform at the start of the marriage but was revealed to me at the end of the marriage. The date of the wedding was 1010 like the scripture John 10:10, but I was spiritually blinded at the time. I created the program

and God was speaking to me through it, but it was concealed. It wasn't until the 2nd marriage that Christ was revealed to me.

Chapter 2 – The Divorce was the Open Door

The divorce was the open door to God's Will for my life, but it was also the closed door to the world's way of living. The divorce was not because the love didn't exist. It was because we were serving two different Gods and became unequally yoked. I had chosen who I was going to serve, and the reality was divorce which is the physical death of a covenant relationship. What God put together let no man separate (Mark 10:9, NKJV) which is why we did not need to involve a lawyer. God was taking me through the process of redemption, and if lawyers got involved for the divorce God's Will for my life would have never manifested. I would not have learned the lesson needed, and consequently would have repeated the cycle. I am grateful that I was unemployed, and I had no money to file the divorce although it appeared as if I filed the papers since he made me the Plaintiff.

He paid the price for the divorce, but I had to give up all the physical possessions attached to his name, and that included the house and eventually the car. I did not understand the process as I was experiencing it, but I understand now. The papers were filed January 6, 2015 and the divorce was final on March 13, 2015. This was a quick work because God needed to shift me into my purpose. He had to give me a certificate of divorce and send me away (Matthew 5:31) because I belonged to the living God through the choice that I made. Once I decided to serve God, I did not have any rights to his money, house, or anything bearing his name. I had to be stripped of all his possessions. When I married him, I did not know who I was in Christ. I spoke about God but served another god. My commitment to the true living God was on Sunday, but Monday through Friday I was serving another god. When I awakened to this reality, my life was turned upside down. Everything I knew was backward. It was my life, but it was not the life that God intended for me. It was an image of God that my ambitions

created for my purposes to survive in the world. I was being blessed, but it was material blessings that were not used to serve the living God. I was not multiplying. I was not having dominion. Everything the bible was saying was not happening in its fullness in my life. I was not laying up treasures in heaven. I knew there was more to life than what I was experiencing. The platform of marriage opened many doors that I walked through blindly, but it also shut doors when I saw the truth. I was married for a season and a reason. Everything I experienced in my life was for God's glory to be revealed on earth as it is in heaven. It was never about me and my problems. It was about overcoming them for the testimony of Jesus Christ who is my Lord, Savior, and King. I couldn't testify about the Good News if I did not experience it for myself.

I had a spiritual death to my marriage while sitting in the house on November 9, 2013. The death brought me to weeping, cleaning, and a spirit of mourning which at the time I didn't realize prepared me for the divorce. Since I was

married for 10 years, it was going to take some time to disconnect from the physical, emotional, social, financial, and mental connections that were created. The passion for my marriage was gone. It was the same experience on August 5, 2013, when I knew the job was going to terminate me from employment which they did on September 12, 2013. I started cleaning my office, cleaning my computer, throwing things away, and working from an empty office. I took my personal belongings that I wanted home. I didn't know the date, but I knew the time was coming because the spirit revealed it to me. This reminded me of how Jesus knew his time was near as stated in John 13:1.

Chapter 3 – Open Door – Job Termination

My job termination was the open door that shifted my life towards heaven and the marriage proceeded. Although the employees didn't believe that I would be terminated because I was a star employee, I prophesied what was going to happen based on what I saw in a vision. It was time for me to take up my cross and be separated from my old life. After my encounter with Christ, I no longer wear carved images because the word says, "You shall not make for yourself a carved image—any likeness of anything that is in heaven above, or that is in the earth beneath, or that is in the water under the earth;" (Exodus 20:4, NKJV). This is the first commandment. I didn't argue with God. I removed all of them out of my house to no longer be worn. Salvation saved me from continuous disobedience to the Almighty God. Jesus Christ knew we would sin against God, and he went to the cross knowing that he would save so many for centuries from going to the lake of fire.

After my encounter with God, from January 11, 2013, to September 12, 2013, was miraculous. The best example I could give is the experience was like *David and Goliath in 1 Samuel 17*. It was also like *Satan and God in battle like Revelation 12*, but God moved me out the way so that he could intervene for victory on earth as it is in heaven. God controlled my mouth during the 9 months. He made sure that they physically won the battle through their carnal weapons of policies and procedures against me, but they lost the war. God allowed everything that happened in that year to occur because I was going through a dying process to the system that I had grown so accustomed to for over 25 years. That year also reminded me of the book JOB when I was told to just quit and find another job. I didn't do anything wrong so what I went through had to have a beginning and end so God could get the victory.

Chapter 4 – Spirit of Peace

After my laboring in 2013, I was at peace and rest in 2014. I began to see rainbows and sometimes double. I saw them in the clouds, after it rained, circling the sun, reflecting off an image like a CD or spraying water, and many other encounters. These encounters were signs to me, and the spirit led me to the scripture Genesis 9:13, “I set My rainbow in the cloud, and it shall be for the sign of the covenant between Me and the earth (NKJV).”. The new covenant was speaking to me, but the old covenant was also being fulfilled. The original promise God made to Noah, Abraham, Isaac, and Jacob is still in effect today for Israel and Judah. The rainbows and the new covenant were comforting to me and gave me peace. I knew I was launched into the Will of God after being terminated. I entered rest for a year then the next trial came which was the divorce. I knew it was coming, but it was by his spirit and not by my self-effort. I couldn't affect the outcome no matter what I did.

We decided on December 22, 2014, to divorce after much counseling. I began to fast and pray. I continued until after the papers were filed on January 6, 2014. I also prayed for a place to stay. God said He would supply all my needs. When I found out through my husband at the time in February that we had the divorce date for March 13, 2015, it was a quick turnaround. Before the date was provided, the Holy Spirit already had shown me a place to apply to live. I followed the instructions. I was approved on February 26, 2015, and I moved on April 10, 2015. Everything happened so fast. I had so much peace when I moved into the apartment. It was for three months until another storm began to brew in the atmosphere. It was okay because I had peace in the storm.

Chapter 5 - Flowing in the anointing

After walking through these experiences for six years, the anointing began to flow in my apartment. The anointing flows like water. It is hard sometimes to catch or keep up with what God is saying because it flows like a rushing river. Through all of my experiences in the past 31 years, I understand why my life took a turn towards destruction when I was eighteen. I am a prophet for God from the line of Judah in the nation of Israel. This is my calling, but when I did not know who I was I was acting as a judge. I was judging people's behaviors instead of interceding and praying for them once I saw their imperfections or corruption. It took me over thirty-one years and many processes to know this information about myself. No one could prophesy this to me or tell me but God in his timing. How do I know this about myself? I know this because of my experience and God directly speaks to me and everything he says comes to pass. I do not need an interpreter or anyone to confirm this

information because God provides me with confirmation through his spirit which can come through people if that is the avenue God chose. I used to believe that the things that were coming to pass in my life were because of my strength. I know that is not the truth now.

Chapter 6 - My Jesus Christ experiences

Everything started with Christ because he is the reason for my salvation in 1987. He is the reason for my experiences. It is his purpose in which I can testify of how he delivered me from destruction. Following Jesus's examples from the Gospels and believing in his words is one part of his teachings but walking with him is another level. When I started believing in one part of the word of God then other scriptures and books unfolded. What I have learned about Jesus in the past 31 years can not be summed up in a book. It can only be touched on because he is everlasting and always showing me different aspects of himself. It's so amazing and the joy of him showing me his love is infinite. I can not do anything for Christ if it is not in love. I was taught the opposite way. I was taught that telling people how I felt was the truth and they were right, but it did not allow the fruit of the Spirit which is love to dwell in my heart. I was using the spirit of judgment and calling it love. The only way

These were all experiences that resurrected as I went through them. I do touch on some of these in my book, “My Faith in the Cross through Salvation...”. In this book, I will touch a little bit on my experience like Daniel.

Chapter 7 - My Daniel experiences

No matter what I was going through, my spirit stayed intact. The situations that were adverse effects made me stronger, better, and more knowledgeable of God's character. I have been thrown into positions and expected to swim or sink? Although the direct manager does not verbally say they wanted me to fail, it's in their actions that they wanted me to fail. I was thrown in the Lion's den and expected to die, but God saved me. I great example is when I was an Operations Manager from 2015 to 2016. My direct manager threw me in a lion's den of managing a larger group without enduring my performance was satisfactory in the smaller group. He threw me in the lion's den, but I was able to shut their mouth when I spoke back about the situation. The move to the larger group was set up to devour me, but God won that battle too. Being terminated from a job didn't mean I lost. It meant I was elevated. The strength God gave me to endure was the example of the anointing God provided me. I can

compare it to Samson's strength. I was thrown in the fire with no water or way out with them watching my actions. God gave me the water to put out the fire by taking a stand and remaining strong and steadfast. My actions expressed who I serve. During this time, I was having dreams that showed me the spirit in which I was working, but the dreams were just warnings. God didn't show me what was happening or prepare me for the push into the Lion's den, but the writing was on the wall. It was clear to me what was happening, but the experience had to run its course until I was terminated.
